AS A RESULT OF THIS CARE, SOI DOG'S ABILITY TO SECURE LOCAL AND FOREIGN ADOPTIONS HAS GROWN DRAMATICALLY WITH OVER 820 BEING PLACED IN HOMES IN THE PAST YEAR.

FINALLY, SOI DOG FOUNDATION USA CONTINUED TO SUPPORT SOI DOG'S MAJOR INITIATIVE TO COMPLETE THE BUILDING OF A NEW, STATE OF THE ART VETERINARIAN HOSPITAL AT THE FOUNDATION'S HEADQUARTERS IN PHUKET. THIS INITIATIVE WAS LAUNCHED IN 2012 VIA SOI DOG'S HANAKO HOSPITAL APPEAL. WITH THE FOUNDATION'S SHELTER IMPROVEMENTS (NEW DOG RUNS, A NEW CAT HOSPITAL, ETC.) COMPLETE, THE MAJOR FOCUS AT THE PHUKET SHELTER WAS TO COMPLETE THE NEW DOG HOSPITAL. THE NEW HOSPITAL WILL PREVENT HIGH RISKS OF CROSS INFECTION, PROVIDE OPTIMAL ENVIRONMENT FOR HEALING, SEGREGATE DOGS BY ILLNESS AND AGE AND INCLUDE MUCH NEEDED MEDICAL TECHNOLOGY LIKE XRAYS. IT IS THE BEST EQUIPPED AND MOST MODERN HOSPITAL OF ITS KIND IN THAILAND AND BE ABLE TO IMPROVE THE NUMBER OF SUCCESSFUL MEDICAL OUTCOMES FOR THE MOST SEVERELY INJURED OR SICK DOGS THAT ARRIVE AT THE SHELTER.
